Commission to Simon Blakebourn, serjeant at arms, to enquire about the captures about March last of 89 tuns of wine of Paitowe belonging to Maurice Claymbroue, Martin de Fontaines, Nicholas le Vassere and Baldwin Clays, merchants of Flanders, of whom James Danwilt and Martin Van Dendorne are proctors, in a ship, of which Jocus Mendre was master, by certain mariners of a barge of Romeneye, of which John William of Smalhithe was master, and on 7 April last of 49 [tuns] and one pipe of wine of Rochelle in a ship called *Gabriel* of Bruges, of which James Perysson was master, laden at Rochelle by James Smyth and John Paul of Flanders his proctor and belonging to them, by an armed balinger of la Pole, of which Henry Cotiller was master, contrary to the form of the treaty between the king and the French, and if the premises are true to make restitution. The like to John Michel, serjeant at arms, to enquire about the captures on SS. Peter and Paul last of a ship called *Garson* of the port of Portugal, of which Roderick Aves is master, laden in Portugal with salt, rabbit-skins and oil to take to Flanders, by four English balingers, viz. one of Herewych, one of Goseford, one of Seint Osyth and another, near Dover with a great sum of gold of the said Roderick and taken to Orwell with the goods in it, and on the same day of a balinger called *Seint Marie* of the port of Portugal of which Laurence de Seosa, servant of the king of Portugal is owner and Dominic Gunsaldus master, laden at Suthampton by Mark le Fayre of Wynechestre and Bartram de Burdeaux with 42 tuns of wine of Gaseony (counting two pipes to a tun) to take to London, by four balingers full of English people of Goseford and Harewych and the adjoining parts, near Dover and taken to Harewych with the wines, and the imprisonment of the said Roderick and his fellows and the servants, masters and mariners, contrary to the form of the treaty between the king and the French, and if the premises are true to make restitution and deliver the prisoners. Commission to Robert Ramsey, John Swyft, clerk, and Robert Derby of Lyverpull to take ships or barges and mariners in the ports of Chester and Lyverpull and other places adjacent for the passage of John Bagot, 'chivaler,' and his men and servants to the king's son Thomas, lieutenant of Ireland.

Commission to John Michel, serjeant at arms, to enquire about the capture on SS. Peter and Paul last of a ship of Portugal sailing to Flanders by four balingers full of English people of Goseford and Harewych, near Dover, with 700 pieces of gold, viz. 'doures,' 'corounes,' 'doucates' and 'florines,' of Aragon, of one Giles Piers and 3½ lasts of hides of one John de Lobellus, merchants of the town of Seint Jake in the kingdom of Castile, and taken to Orford by Harewych with the merchants and goods, contrary to the form of the treaty between the king and the king of Castile, and if the premises are true to make restitution.
